

NORTHERN FUNDS AND NORTHERN INSTITUTIONAL FUNDS 2018 CAPITAL GAIN DISTRIBUTIONS

At least once a year, mutual funds must distribute to shareholders any capital gains realized from selling securities within the funds. In 2018 Northern Funds and Northern Institutional Funds paid capital gain distributions on December 20 to shareholders of record as of December 19.

The table below lists per share distribution amounts — dividends and short- and long-term gains — for both Northern Funds and Northern Institutional Funds. These amounts will also be reported on year-end statements.
